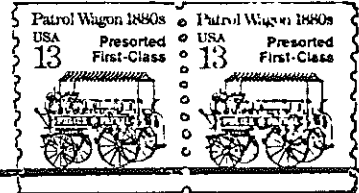
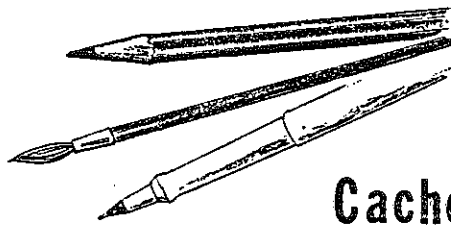

SPOT LIGHT:

Andrew C. Doback

I began my A.C. Doback cachet line with the 1986 Connecticut Postal Card. I planned to get about 15 different cancels, and I didn't want them all to have the same cachet design.

Rather than incurring printing costs for 15 small runs, I decided that one printed text and a small Crosby-size photo would be most economical. However, what I saved in money, I lost in labor since the photos have to be cut and pasted.

The question I'm asked most is "how do you get the photos so small?" The photos are actually negative-sized prints known as contact or proof sheets. In this process, the negative strips are laid placed side-by-side and printed on 8 x 10 photographic paper. Six strips of 6 negatives can be printed per sheet equalling 36 photos.

That's the easy part. The real pain is cutting the individual photos from the contact sheet. But maybe even worse is the pasting! For this I use a sponge top-tube of liquid glue.

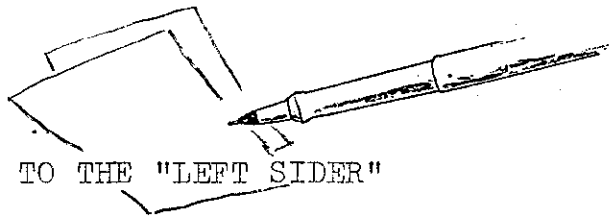
I'm also asked about the actual photography since most of my subject matter is from books, magazines, post cards, small toys, etc. I use a close-up lens kit which has three different magnifying lenses. The close-up lens is attached to the camera lens in the same manner as a filter. The lenses may be used singly or in combination for greater magnification. □

A complete addendum showing all additions and changes and incorporating intermediate addenda will be prepared for distribution at the 1989 AFDCS Convention.

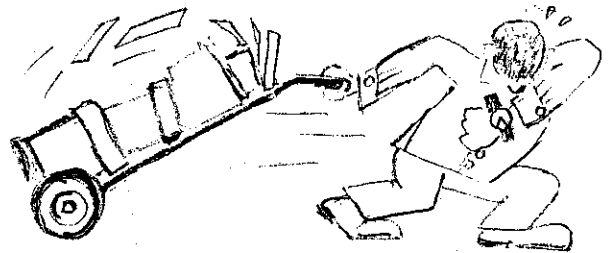
